OFFICIAL CALL

Party Canvass and Electing Delegates to the State Convention Gloucester County Republican Party of the Republican Party of Virginia

As Chairman of the Gloucester County Republican Committee (GCRC) of the Republican Party of Virginia (RPV), and pursuant to the RPV Plan of Organization (the "Party Plan") and as recommended and directed by the GCRC, I, Ashley C. Chriscoe, do hereby issue this call for a Party Canvass and Electing State Convention Delegates as follows:

- A. A Party Canvass shall be held on June 7, 2021 starting promptly at 12:00 p.m. and ending promptly at 6:00 p.m. local time at Grace Covenant Presbyterian Church, 6470 Main St., Gloucester, VA 23061 for the purpose of Nominating a Republican candidate for each of the following elected offices to be voted for in the General Election on November 2, 2021:
 - 1) Clerk of the Circuit Court
 - 2) Member, Board of Supervisors, Petsworth District, Gloucester County
 - 3) Member, Board of Supervisors, York District, Gloucester County
 - 4) Member, Board of Supervisors, At-Large, Gloucester County

--AND-

- B. Electing Delegates to represent Gloucester County Republicans at the Republican Party of Virginia's 2021 State Convention which will be held on May 8, 2021, from 9:00 a.m. and ending promptly at 4:00 p.m. at remote voting locations across the Commonwealth of Virginia. The State Convention voting location for Gloucester County Delegates shall be at Grace Covenant Presbyterian Church, 6470 Main St., Gloucester, VA 23061, beginning at 9:00 a.m. and ending promptly at 4:00 p.m. local time. The purpose of the Convention is to nominate one Republican candidate each for the offices of:
 - 1) Governor of Virginia
 - 2) Lieutenant Governor of Virginia
 - 3) Attorney General of Virginia

Since RPV has not limited the number of State Convention Delegates from each county/city unit committee, GCRC will not hold a voting event to elect Delegates because no over-filing is possible and, therefore, all qualified persons properly filed to be delegates shall be deemed elected and will cast Gloucester County's 92 delegate votes in the 2021 Republican Party of Virginia State Convention.

Qualifications for Participation

All legal and qualified voters of Gloucester County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing, as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in this Gloucester County Republican Party Canvass, subject to the provisions in Article I of the RPV Plan of Organization. In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years. A single exception shall be approved for a voter who renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and

intends, at the time of the writing, to support the nominees of the Republican Party in the ensuing election and in the future. Any voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter. In order to participate, Party Canvass voters must present a photo ID to verify their identity.

Prefiling Requirements and Fees

<u>Candidates</u>: All candidates for election to public office at said Party Canvass shall prefile (1) a written statement of intent and qualifications to seek the Gloucester County Republican Party's nomination for the respective office, which <u>must</u> include commitment not to seek election in the ensuing General Election other than as the Republican nominee for the elected office for which prefiled in this Party Canvass, AND (2) all candidates shall submit, for the office sought, the applicable and properly completed "Official Gloucester County Republican Party Canvass Prefile Form" and non-refundable filing fee(s) in the amount stated on the applicable Prefile Form, with the Chairman, Gloucester County Republican Party, Ashley C. Chriscoe by U.S. Mail or physical delivery to 7871 Paynes Landing, Gloucester, VA 23061. Postmarks shall not govern. Prefiling fees are non-refundable. The applicable prefiling statement, form and non-refundable filing fee(s) for all elected offices must be received by Chairman Chriscoe not later than Saturday, April 17, 2021 at 5:00 p.m. local time.

<u>Delegates to State Convention</u>: The Republican Party of Virginia's "2021 State Convention Delegate Filing Form" for Gloucester County Delegates to the Republican Party of Virginia 2021 Convention must be received not later than Saturday, April 17, 2021 at 5:00 p.m., by the Chairman, Gloucester County Republican Party, Ashley C. Chriscoe by U.S. Mail or physical delivery to 7871 Paynes Landing, Gloucester, VA 23061. Postmarks shall not govern. There are no fees for filing to be a delegate.

Due to USPS Mail delays related to COVID-19, to ensure meeting the prefiling deadline, all prefiling materials may be physically delivered Chairman Ashley C. Chriscoe at 7871 Paynes Landing, Gloucester, VA 23061, from 10:00 a.m. to 5:00 pm on Saturday, April 17, 2021. If the GCRC is able to hold an inperson regular monthly meeting on Thursday, April 15, 2021, prefile materials may be dropped off at that meeting.

Cancellation

If not more than the number of persons to be nominated or elected shall pre-file for any office, then such properly filed persons shall be declared nominated or elected as the case may be, and no election will occur for that office. If not more than the number of persons to be nominated or elected shall pre-file for all offices listed for this Party Canvass, then all such properly filed persons shall be declared nominated or elected as the case may be, and this Party Canvass shall be cancelled. A notice of cancellation will be posted on the website of the Republican Party of Virginia www.virginia.gop.

Publication of the Call

This Official Call shall be posted on the website of the Republican Party of Virginia $\underline{www.virginia.gop}$ and the website of the 1st Congressional District Committee $\underline{www.va01republicans.org}$. The GCRC has eliminated the requirement to publish this Call in a newspaper of general circulation by a two-thirds vote.

Registration Fee

There is no registration fee to participate in this canvass or to be a delegate to the State Convention.
