OFFICIAL CALL

Mass Meeting Grayson County Republican Committee of the Republican Party of Virginia

As Chairman of the Grayson County Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, James D. Wagoner, do hereby issue this call for a Mass Meeting to be held at Pizza Plus, 106 Grayson Avenue, Independence, VA 24348, on Monday, May 24, 2021, starting at 6:00 p.m. local time for the following purpose:

- 1. Nominating a Republican candidate for Grayson County Board of Supervisor for the Elk Creek Magisterial District and for Grayson County Board of Supervisor for the Wilson Magisterial District to be voted upon in the November 2, 2021 General Election;
- 2. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Grayson County from the Elk Creek Magisterial District and the Wilson Magisterial District under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the forgoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter.

Voters may be required to produce personal identification such as a valid photo ID that is acceptable for voting purposes in order to participate.

Filing Requirements

Candidates for election for a member of the Board of Supervisors for the Elk Creek Magisterial District or a member of the Board of Supervisors for the Wilson Magisterial District at said mass meeting shall file a written statement by mail or in person, to James D. Wagoner, 673 Rock Chimney Road, Galax, VA 24333 or Susan Herrington, P.O. Box 130, Independence, VA 24348, or Larry D. Bolt, P.O. Box 126, Independence, VA 24348, which must be received not later than May 10, 2021 at 7:00 p.m. and accompanied by any fees required. Postmarks shall not govern. Candidate forms may also be presented at the regular monthly meeting of the Grayson County Republican Party to be held on May 10, 2021, at 6:00 p.m. at Pizza Plus, Independence, VA 24348. Forms must be presented by 7:00 p.m.

Candidacy filing fees are as follows:

County Board of Supervisors for the Elk Creek Magisterial District or Wilson Magisterial District:
 \$100.00 filing fee. Checks are to be made payable to the Grayson County Republican Committee.

Uncontested Offices/Cancellation of Mass Meeting

If no more than one candidate properly files for election to any office to be voted upon at the mass meeting, that candidate will be declared elected. If there are no contested offices to be voted upon at the mass meeting, then no mass meeting will be held.
