

## OFFICIAL CALL for a Mass Meeting of the Halifax County Republican Party

As Chairman of the Halifax County Republican Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Korey R. Snead, do hereby issue this call for a Mass Meeting of the Halifax County Republican Party to be held at the World of Sports, **or alternate location**, starting at 7:00pm local time on Friday, April 3, 2020 for the following purposes:

- a) Electing a Committee Chairman;
- b) Electing members of the Halifax County Republican Committee pursuant to the State Party Plan of Organization;
- c) Electing up to 320 Delegates and an equal number of Alternates to the 5<sup>th</sup> Congressional District Convention, to be held on the 25<sup>th</sup> of April 2020 at 2812 Greenview Drive, Lynchburg, Virginia, 24502, beginning at 10:00am for the following purposes:
  - 1) Election of 3 National Delegates for the 2020 Republican National Convention;
  - 2) Election of 3 Alternate National Delegates for the 2020 Republican National Convention:
  - 3) Election of 3 State Central Committee Members:
  - 4) Election of 1 Elector for the 2020 Presidential Election:
  - 5) Election of District Committee Chairman;
  - 6) Election of Republican Nominee for U.S. House;
  - 7) Transaction of such other business as may properly come before the Convention.
- d) Electing up to 320 Delegates and an equal number of Alternates to the Republican Party of Virginia's Statewide Convention, to be held May 1<sup>st</sup>-2<sup>nd</sup>, 2020 at the Greater Richmond Convention Center, for the following purposes:
  - 1) Binding Virginia Delegates to the 2020 Republican National Convention as to their choice for President on the first ballot by a Presidential Preference Poll;
  - 2) Electing 12 At-Large Delegates ("National Delegates") and 12 At-Large Alternate Delegates ("National Alternates") to the Republican National Convention to be held on August 24-27, 2020 at the Spectrum Center, Charlotte, NC in (or its alternate site):
  - 3) Nominating two Electors At-Large to be voted for in the presidential election on November 3, 2020;
  - 4) Electing a State Chairman;
  - 5) Nominating a National Committeeman and National Committeewoman;
  - 6) And for the transaction of such other business as may properly come before the Convention.

e) and for the transaction of such other business as may properly come before the mass meeting.

## **Qualifications for Participation**

All legal and qualified voters of Halifax County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts.

Otherwise Qualified Military Members who declare via electronic mail to the local Chairman, as specified in the Call for the Convention, that because of the obligations of their official military orders, they are unable to attend their respective Unit mass meeting, canvass or convention called for the purpose of selecting delegates to a Convention, and that in lieu of selecting delegates to represent them from their respective Unit they instead wish to be represented by the Military Delegation, shall be entitled to representation via the Military Delegation.

## **Filing Requirements**

The filing requirements shall be as follows:

- a) Candidates for the position of Committee Chairman by said mass meeting shall pre-file the approved form attached to this call (or available by request to the Chairman at <a href="krsnead2@gmail.com">krsnead2@gmail.com</a> or 434-579-6085 at, or after, the date of publication) along with the \$250.00 dollar filing fee (payable to the Halifax County Republican Committee) by mail, or in person, to Chairman Snead at P.O. Box 3, Scottsburg, Virginia 24589, or in person at 3166 South Terry's Bridge Road, Scottsburg, Virginia Monday Friday between the hours of 1:00pm and 4:00pm by no later than 4:00pm on Monday, March 9<sup>th</sup>, 2020. Postmarks shall not govern.

- d) Candidates for election as Delegate to the Republican Party of Virginia's State Convention by said mass meeting may pre-file the approved form attached to this call (or available by request to the Chairman at <a href="krsnead2@gmail.com">krsnead2@gmail.com</a> or 434-579-6085) by mail, electronic mail, or in person, to Chairman Snead at P.O. Box 3, Scottsburg, Virginia 24589, <a href="krsnead2@gmail.com">krsnead2@gmail.com</a>, or in person at 3166 South Terry's Bridge Road, Scottsburg, Virginia Monday Friday between the hours of 1:00pm and 4:00pm by no later than 4:00pm on Tuesday, March 31st, 2020. Postmarks shall not govern. Candidates may also file during the said mass meeting.
- e) Otherwise Qualified Military Members who wish to be represented by the Military Delegation shall send an electronic mail declaration which shall include (or be attached) a signed statement of intent to support all Republican Nominees in the General Election, an affirmation of their official military orders precluding their attendance, and their electronic mail address for correspondence. The declaration shall be emailed to krsnead2@gmail.com not later than 4:00pm on Tuesday, March 31<sup>st</sup>, 2020. Subsequent to the receipt of the Declaration, Qualifying Military Members will be sent a Ballot Preference Form to be returned by email, as directed, prior to the Convention. Any otherwise qualified Delegate who would like to serve in the Military Delegation in lieu of serving as a Delegate for their Unit should notify their Unit Chairman along with their Delegate application.

## **Registration Fee**

There will be no registration fee to participate in this mass meeting.
