Official Call to Canvass

As Chairman of the Halifax County Republican Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Korey R. Snead, do hereby issue this call for a Party Canvass to be held at the office of Delegate James Edmunds at 60 South Main Street, Halifax, Virginia, from 4:00P.M. until 7:00P.M. local time on Monday, the 10th of June, for the purpose of Nominating Republican Candidates for the offices of **Sheriff, Commonwealth's Attorney, Commissioner of the Revenue, Treasurer, and Members of the Board of Supervisors (Tie-Breaker, District 1, District 4, District 5, District 7, and District 8)** to be voted for in the general election on Tuesday, the 5th of November, 2019

Qualifications for Participation

All legal and qualified voters of Halifax County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for the nomination or election at said canvass shall file the provided Filing Form by electronic mail (E-mail) or in person, to Chairman Korey R. Snead at krsnead2@gmail.com or at 3166 South Terry's Bridge Road, Scottsburg, Virginia by Thursday, the 6th of June, by 4:00P.M. local time. If not more than the number of persons to be elected shall file for each office (with the exception of the office of Sheriff), then such properly filed person shall be declared nominated, and no canvass will be held for such purpose.
