
## **Qualifications for Participation**

All legal and qualified voters of Halifax County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

## **Filing Requirements**

Candidates for the nomination or election at said canvass shall file the provided Filing Form by electronic mail (E-mail) or in person, to Chairman Korey R. Snead at <a href="krsnead2@gmail.com">krsnead2@gmail.com</a> or at 3166 South Terry's Bridge Road, Scottsburg, Virginia by Thursday, the 6<sup>th</sup> of June, by 4:00P.M. local time. If not more than the number of persons to be elected shall file for each office (with the exception of the office of Sheriff), then such properly filed person shall be declared nominated, and no canvass will be held for such purpose.
