OFFICIAL CALL

Mass Meeting of the Republican Party of Hampton City Committee of the Republican Party of Virginia

As Chairman of the Republican Party of Hampton City Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Philip S. Siff, do hereby issue this call for a Mass Meeting to be held at Anna's Restaurant, 2845 N. Armistead Ave, Hampton, VA 23666, or its alternate site, starting at 2:00 PM local time on Saturday, March 27, 2021 for the following purposes:

1. To elect up to 590 Delegates and an equal number of Alternates to the Republican Party of Virginia State Convention, to be held on May 8, 2021 at the Liberty University, 1971 University Blvd, Lynchburg, VA 24515, beginning at 9:00 AM for the purpose to nominate one Republican candidate each for the offices of Governor of Virginia, Lieutenant Governor of Virginia, and Attorney General of Virginia in the General Election to be held on November 2, 2021, and for the transaction of such other business as may properly come before the convention. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at last election, so that the Republican Party of Hampton is entitled to 118 Delegate Votes.

Qualifications for Participation

All legal and qualified voters of the City of Hampton, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. Any member of the United States Armed Forces, the Coast Guard, the Merchant Marine or the Virginia National Guard who is otherwise qualified under Article I of the Party Plan and who complies with the procedures to become a delegate to the Convention, or to any mass meeting or party canvass called for the purpose of selecting delegates to it, and who produces valid military identification or other proof of active duty status shall be certified as a delegate, and shall not be required to be elected as a delegate. Military delegates who are unable to participate in the Convention in person due to obligations of their official military orders shall have their votes cast within their respective unit delegations, via ballots prepared and distributed by the RPV Chairman at least 20 days prior to the Convention and returned to the RPV Chairman no later than 5:00 p.m. on May 6, 2021. Postmarks, or other proof of posting or dispatch, shall not govern.

Pre-Filing Requirements

Any person who wishes to be a Delegate or Alternate Delegate to the Convention must complete the **Notice of Candidacy Form**. Official Notice of Candidacy Forms may be downloaded at www.virginia.gop or will be available from Chairman Philip Siff at HamptonGOP@gmail.com. Notice of Candidacy Forms must bear the signature of the candidate and may be transmitted via email.

Scans and photos are acceptable as long as all information including signature is legible. Electronic signatures are not allowed.

The application must be received by Chairman Philip Siff **no later than 7:00 pm, local time, Monday, March 22, 2021.** The Notice of Candidacy Form must be transmitted to Republican Party of Hampton, c/o Philip Siff, 4017 Chesapeake Ave, Hampton, VA 23669 (postmarks do not govern) or email as an attachment to HamptonGOP@gmail.com. Scans and photos are acceptable as long as all information including signature is legible. Hand delivery by appointment only. Any questions contact 757-848-6344.

Only those who have properly Pre-Filed can be nominated at the Mass Meeting. No nominations may be made from the floor of the Mass Meeting for any Delegate by virtue of the pre-filing requirements. If fewer than the maximum number of delegates for each Convention files for election, all qualified candidates may be declared elected and the Mass Meeting may be cancelled by the Chairman.

Properly Pre-filed Candidates for Delegates to the State Convention need NOT attend the Mass Meeting on March 27, 2021, to be elected as Delegate to the Republican Party of Virginia State Convention.

Resolutions

Resolutions must be submitted by the Pre-file Deadline (March 22) to the Hampton Chairman to be considered by the Resolutions Committee. No Resolutions may be submitted from the floor of the Mass Meeting.

Registration and Fees

The doors will open at 1:00 PM with registration to begin at 1:15 PM. Registration shall not be closed prior to 2:00 PM. A photo I.D. will be required to participate in this Mass Meeting. A current voter registration card would help expedite the registration process. No fees are required.
