

## **Official Call for a Mass Meeting King and Queen County Republican Committee**

As Chairman of the King and Queen County Republican Committee of the Republican Party, and pursuant to the Plan of Organization, and as recommended and directed by the Committee, I, William H. Rilee do hereby issue this notice and call for a Mass Meeting to be held at Nick's Restaurant, 3483 Shackelfords, Virginia 23156 starting at 7:00 p.m. local time on Tuesday, June 2, 2020. Registration will begin at 6:30 p.m.

1. Elect 75 Delegates and Alternates to represent the Committee at the State Convention of the Republican Party of Virginia date to be determined, at Greater Richmond Convention Center, 403 N 3<sup>rd</sup> Street, Richmond, VA 23219.
2. Elect 75 Delegates and Alternates to represent the Committee at the 1<sup>st</sup> District Republican Convention which shall be held on Caroline County High School, 19155 Rogers Clark Boulevard, Milford, VA 22514, Saturday, June 13, 2020 at 1:00 p.m. local time.
3. Elect a Chairman of the King and Queen County Republican Committee.
4. Elect members of the King and Queen County Republican Committee.
5. Transact such other business as may properly come before the Mass Meeting.

### **Qualifications for Participation**

All legal and qualified voters of King and Queen County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

### **Voluntary Filing Fees for the District and State Conventions**

A candidate filing fee of \$35.00 is requested of each person standing for election as a delegate or alternate delegate to the State Convention. Any delegate who fails to pay the registration fee may participate only in the Presidential Preference Poll.

A voluntary candidate filing fee of \$5.00 is requested of each person standing for election as a delegate or alternate to the First District Convention.

Failure to pay the requested voluntary filing fee will not result in disqualification.

The Chairman of the King and Queen County Republican Committee recommends that all Delegates and Alternates to the District and State Conventions pay the voluntary fees.

### **Election of Convention Delegates and Alternates, Chairman and Committee Members**

Persons seeking election as Convention Delegates, Convention Alternates, Committee Chairman and Committee Members are encouraged to be physically present at the Mass Meeting.

The pre-filing deadline for this mass meeting is 5:00 PM on May 30, 2020. At the closing of the pre-filing deadline, if the number of persons pre-filing as candidates for election at the Mass Meeting does not exceed the number to be elected, then the pre-filed candidates will be declared elected and the Mass Meeting will be canceled.

**Registration Fee**

There will be no registration fee to participate in the Mass Meeting. A photo ID will be required to be presented for participation at this Mass Meeting as well as at the First Congressional District Republican Convention.

The full Call to the of the King and Queen County Mass Meeting will be available on the RPV website and the First Congressional District website. All pre-filing forms for the State Convention and the First District Convention are also available on those websites. The Committee voted not to publish in local publication.
