Mass Meeting of the Lee County Committee of the Republican Party of Virginia

As Chairman of the Lee County Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Travis Mullins, do hereby issue this call for a Mass Meeting to be held at the Lee County Republican Party Headquarters, 33692 Main Street, Jonesville, Virginia 24263 or its alternative site, starting at 6:30 p.m. local time on March 19, 2020 for the following purpose:

- 1. Electing a Lee County Republican Committee Chairman;
- 2. Electing Officers of the Lee County Republican Committee as follows: Vice-Chairman, Secretary, and Treasurer;
- 3. Electing up to 255 Delegates and an equal number of Alternates to the Republican Party of Virginia State Convention, to be held on Friday, May 1, 2020 and Saturday, May 2, 2020, at Liberty University, Vines Center, 1971 University Blvd, Lynchburg, VA 24502, or its alternate site, opening at 2:30 p.m. on May 1 for the purposes of:
 - a. electing a State Chairman,
 - b. nominating a National Committeeman and National Committeewoman,
 - c. electing 12 at-large delegates and 12 at-large alternate delegates to the 2020 Republican National Convention,
 - d. binding Virginia Delegates to the 2020 Republican National Convention as to their choice for President on the first ballot by a Presidential Preference Poll,
 - e. nominating 2 electors at-large to serve in the 2020 Electoral College, and
 - f. the transaction of other business as may properly come before the Convention.
 - g. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes cast for Governor and President at their last election, so that Lee County is entitled to 51 Delegate Votes;
- 4. Electing up to 255 Delegates and an equal number of Alternates to the Ninth Congressional District Republican Convention, to be held on Saturday, April 18, 2020 at George Wythe High School, #1 Maroon Way, Wytheville, VA 24382, or its alternate site, beginning at 10:00 a.m. (with registration from 8:00 a.m. to 10:15 a.m.) for the purposes of:

- a. electing a District Chairman,
- b. electing 3 members to the State Central Committee,
- c. electing 3 delegates and 3 alternate delegates to the 2020 Republican National Convention,
- d. nominating 1 elector to serve in the 2020 Electoral College, and
- e. the transaction of other business as may properly come before the Convention.
- f. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes cast for Governor and President at their last election, so that Lee County is entitled to 51 Delegate Votes;
- 5. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Lee County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for election as Chairman, Vice-Chairman, Treasurer, or Secretary of the Lee County Republican Committee are required to pre-file their intention to seek such offices. A written statement of intent (Committee Membership Application) containing the following details shall be required: full legal name, office sought, physical and mailing address, email address, and telephone number. Applications can be downloaded from the Republican Party of Lee County website at www.leevagop.com. Applications must be RECEIVED by 5:00 p.m. on Thursday, March 12, 2020 by mail. Applications shall be addressed to the Lee County Republican Committee, P.O. Box 101, Jonesville, VA 24263. Postmarks shall not govern. No statements in any form will be accepted after the aforementioned deadline.

Individuals seeking to be delegates or alternates to the district convention or members of the Lee County Republican Committee are also required to pre-file. Individuals wishing to be elected delegates or alternates to the district and/or state conventions much pre-file to assist us with preparing for the Mass Meeting. If anyone has questions, they may contact Chris Jones

prior to the Mass Meeting pre-file date for information on how to be considered for election at the Mass Meeting.

If no more than one candidate files for election to any office to be voted upon at the mass meeting, that candidate will be declared elected. If fewer than the maximum number of unit committee members that Lee County Republican Committee has established pre-file, all properly pre-filed candidates shall be declared elected to the applicable unit committee membership position. If fewer than the maximum number of Delegates that Lee County is entitled to at any convention pre-file, all properly pre-filed candidates shall be declared elected. If there are any Committee positions that no one pre-filed for or any vacant Delegate or Alternate Delegate positions, motions may be made from the floor at the Mass Meeting to fill those positions.

Registration Fee

There will be NO registration fee to participate in this Mass Meeting or to seek any position within the Lee County Republican Committee.

- Delegate/Alternate Delegate to the Republican Party of Virginia State Convention \$35.00 registration fee (Any delegate who fails to pay the registration fee may participate only in the Presidential Preference Poll).
- Delegate/Alternate Delegate to the Ninth District Republican Convention \$10.00 registration fee (voluntary).

Please make checks payable to the Lee County Republican Committee, which will forward the registration fee to the Ninth Congressional District Republican Convention or the Republican Party of Virginia (Whichever is applicable).
