- Repeated failure to fully comply with a May 1<sup>st</sup>, 2019 motion adopted by the RPV 97<sup>th</sup> Legislative District Committee to cancel the Convention on May 4<sup>th</sup>, 2019.
- 3. Circumventing the majority vote of the 97th Legislative District Committee by appointing committees and otherwise assuming Duties clearly prescribed by actions taken of the 97th Legislative District Committee without consultation or authorization.
- 4. Failure to provide members of the 97th Legislative District Committee with a reasonable time to review and consider the proposed May 4<sup>th</sup>, 2019 budget and convention rules prior to proposed adoption by the 97th Legislative District Committee.
- 5. Repeated disregard for the minimal rights of members of the 97th Legislative District Committee to participate in discussion and debate at the April 27<sup>th</sup> and May1st, meetings by refusing to recognize members attempting to speak, denying properly made motions and failing to ascertain the required second and majority vote to adjourn.
