# OFFICIAL CALL Mass Meeting of Republican Orange County Committee of the Republican Party of Virginia March 12<sup>th</sup> 2020. Orange, Virginia.

As Chairman of the Republican Orange County Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Jordan C. Marshall, do hereby issue this call for a Mass Meeting to be held at Madison at the Mill, 323 Madison Rd. Orange, Va. 22960, or an alternate site if necessary. Registration will begin at 5:00 PM. The meeting will start at 7:00 PM on Thursday, March 12, 2020 for the following purposes:

- To elect up to 860 Delegates and an equal number of Alternates to the Seventh Congressional District Republican Convention, to be held on Saturday, April 25, 2020 in the Arthur Ashe Junior Athletic Center, 3001 N Arthur Ashe Blvd, Richmond, VA 23230 or an alternate site if necessary, beginning at 10:00 AM. The purposes of the District Convention are:
  - a. Electing a District Chairman;
  - Nominating a Republican candidate for member of the U.S. House of Representatives to be voted for at the election on Tuesday, November 3, 2020;
  - c. Electing three members of the State Central Committee for a term of four years or until their successors are elected;
  - d. Electing three delegates and three alternate delegates to the Republican National Convention to be held in Charlotte, NC on August 24<sup>th</sup> through August 27<sup>th</sup> 2020;
  - e. Electing an Elector for Electoral College;
- To elect up to 250 Delegates and an equal number of Alternates to the State Convention of the Republican Party of Virginia, to be held on May 1-2<sup>nd</sup> at the Greater Richmond Convention Center at 403 North 3<sup>rd</sup> Street

Richmond, VA 23219 or its alternate site starting at 2:30 PM on 5/1 and 10:00 AM on 5/2. The purposes of the State Convention are:

- Binding Virginia Delegates to the 2020 Republican National Convention as to their choice for President on the first ballot by a Presidential Preference Poll;
- b. Electing 12At-Large Delegates ("National Delegates") and 12 At-Large Alternate Delegates ("National Alternates") to the Republican National Convention to be held on August 24-27,2020 at the Spectrum Center, Charlotte, NC in (or its alternate site)(the "National Convention");
- c. Nominating two Electors At-Large to be voted for in the presidential election on November 3, 2020;
- d. Electing a State Chairman;
- e. Nominating a National Committeeman and National Committeewoman;
- f. And for the transaction of such other business as may properly come before the Convention
- 3. To elect a Chairman of the Republican Orange County Committee;
- 4. Electing members of the Republican Orange County Committee;
- 5. To transact other business as may properly come before the mass meeting.

### **Qualifications for Participation**

All legal and qualified voters of Orange County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party, and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts. Voters may be required to produce personal identification such as a valid driver's license or voter registration card and or sign a form stating they are a registered in Orange County, Virginia

## Filing Requirements

Members in good standing of the Republican Orange County Committee must pre-file as a candidate for Chairman of the Republican Orange County Committee listed above must file a "Declaration of Candidacy" form, it must be received on or before 6:00 PM, March 4, 2020. The form is available on <u>www.virginia.gop</u> or by contacting Mr. Jordan C. Marshall at <u>jmarshall1848@gmail.com</u> (540-223-0617). The form is to be sent to Mr. Jordan C. Marshall at 11518 Greenview Dr. Orange, Va. 22960, in person or by mail or email to <u>jmarshall1848@gmail.com</u>. Postmarks will not be considered. If no more than one candidate or less than the maximum number of delegates files for election to the office to be voted upon at the mass meeting, the election for that position will be canceled and that candidate or delegate will be declared elected.

Any person wishing to file for election as a Delegate or Alternate to either the 7th District Convention or State Convention must file a "Declaration of Candidacy" form; it must be received on or before 6:00 PM, March 4, 2020. ### **Registration Fee**

There is a voluntary \$25 registration fee for the 7th District Convention. In order to vote in any election for District Chairman or State Central Committee member

(at the 7<sup>th</sup> District Convention), the \$25.00 registration fee is a mandatory requirement.

A Delegate Registration Fee of Thirty-Five Dollars (\$35.00) is requested of each person standing for election as a delegate or alternate delegate to the State Convention. Any delegate who fails to pay the registration fee may participate only in the Presidential Preference Poll.

There will be a \$5.00 voluntary registration fee to participate in the ROCC mass meeting. Voluntary or mandatory fees may be paid at the mass meeting, payable to the ROCC, 11518 Greenview Dr. Orange, Va. 22960.

## **Cancellation**

If not more than the number of persons to be nominated or elected shall file for any office, then such properly filed persons shall be declared nominated or elected as the case may be, and no election will occur for that office. Should all elections be canceled, the Mass Meeting will also be canceled. Notice of cancellation will be posted on the website of the Republican Party of Virginia <u>www.virginia.gop</u> and by email from the ROCC Chairman.
