As Chairman of the Prince George County Republican Committee, and pursuant to the Plan of Organization of the Republican Party of Virginia and as recommended and directed by the Committee, I, Carolyn Day R. Pruett, do hereby issue this call for a Mass Meeting to be held at Roma Ristorante Italiano, 2447 County Drive, Petersburg, VA 23803, (or alternate location) starting at 7:00pm EDT on Monday, April 6, 2020, (Registration begins at 6:00pm EDT) for the following purposes:

- 1. Electing a Unit Chairman;
- 2. Electing members of the Prince George County Republican Committee as follows:

- 3. Electing up to 304 Delegates and an equal number of Alternates to the District Convention of the 4th Congressional District, to be held on April 25, 2020, at Thomas Dale High School West Campus, beginning at 11:30am for the purpose of:
  - A. Electing a District Chairman;
  - B. Nominating a Republican candidate for member of the U.S. House of Representatives to be voted for at the election on Tuesday, November 3, 2020;
  - C. Nominating a Republican candidate for elector for President and Vice-President of the United States to be voted for at the election on Tuesday, November 3, 2020;
  - D. Electing three members of the State Central Committee for a term of four years or until their successors are elected;
  - E. Electing three delegates and three alternate delegates to the Republican National Convention to be held in Charlotte, NC on Mon, August 24, 2020 Thu, August 27, 2020
  - F. and for the transaction of such other business as may properly come before the convention.
- 4. Electing up to 61 Delegates and an equal number of Alternates to the State Convention, to be held on May 1-2, 2020, at the Greater Richmond Convention Center, beginning at 2:30pm EDT on May 1, 2020, and 10:00am EDT on May 2, 2020, for the purpose of:
  - A. Binding Virginia Delegates to the 2020 Republican National Convention as to their choice for President on the first ballot by a Presidential Preference Poll;
  - B. Electing 12 At-Large Delegates ("National Delegates") and 12 At-Large Alternate Delegates ("National Alternates") to the Republican National Convention to be held on August 24-27, 2020 at the Spectrum Center, Charlotte, NC in (or its alternate site) (the "National Convention");

- C. Nominating two Electors At-Large to be voted for in the presidential election on November 3, 2020;
- D. Electing a State Chairman;
- E. Nominating a National Committeeman and National Committeewoman;
- F. And for the transaction of such other business as may properly come before the Convention.

and such other business as may properly come before the mass meeting.

# **Qualifications for Participation**

All legal and qualified voters of Prince George County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia participate in this Mass Meeting, subject to the provisions in Article I of the Plan of Organization.

Mass Meeting participants must present one of the forms of identification listed in § 24.2-643 of the Code of Virginia in order to participate.

Participants may pay a voluntary registration fee of \$10.00.

## Filing Requirements

Candidates for election or nomination at this Mass Meeting shall file a written statement with Susan Fierro by mail or by physical delivery at 10432 Jordan Parkway, Hopewell, VA 23860. The written statement must be received by the deadline; postmarks are not evidence of receipt by the deadline.

Candidates for election as Unit Chair must file the written statement by 5:00pm EDT on Friday, April 3, 2020, and shall include with their written statement a check or evidence of payment of a \$50.00 filing fee.

Candidates for election to membership of the Prince George County Republican Committee must file the written statement by 5:00pm EDT on Friday, April 3, 2020, and shall include with their written statement a check or evidence of payment of a \$25.00 filing fee (annual dues).

Candidates for election as delegate or alternate to the 4th Congressional District Republican Convention must file the written statement by 5:00pm EDT on Friday, April 3, 2020. There is no filing fee required for the 4th Congressional District Convention.

Candidates for election as delegate or alternate to the State Convention of the Republican Party of Virginia must file the written statement by 5:00pm EDT on Friday, April 3, 2020, and shall include with their written statement a check or evidence of payment of a \$35.00 filing fee. Any delegate who fails to pay the registration fee may participate only in the Presidential Preference Poll.

#### Military Members as Delegates

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) who comply with these filing requirements shall not be required to be elected, but shall be declared delegates pursuant to Article VIII, Section H. of the Plan of Organization of the Republican Party of Virginia.

Military Member delegates or alternate delegates that are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within their unit delegation according to candidate preference ballots. Instructions regarding the casting of candidate preference ballots are available in the Call for the Convention, which is available on the website of the Republican Party of Virginia (https://virginia.gop/).

### Cancellation

If not more than the number of persons to be nominated or elected shall file for any office, then such properly filed persons shall be declared nominated or elected as the case may be, and no election will occur for that office. Should all elections be cancelled, the Mass Meeting will also be cancelled and a regular committee business meeting shall occur instead.

### Publication

This Call shall be posted on the website of the Republican Party of Virginia (https://virginia.gop/) and the Prince George County Republican Committee waived the newspaper publication requirement by a two-thirds vote.
