## **OFFICIAL CALL**

Mass Meeting of The Radford City Republican Committee of the Republican Party of Virginia

As Chairman of the Radford City Republican Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, John W. L. Craig II, do hereby issue this call for a Mass Meeting to be held on April 13th, 2021, at 7:00 p.m. at Veterans of Foreign Wars Building, 102 Watts Street, Radford, Virginia for the following purposes:

1. Electing delegates to the Republican Party of Virginia 2021 Convention, to be held on May 8, 2021, location to be announced, beginning at 9:00 a.m. and ending at 4 p.m. for the purposes of:

a) nominating one Republican candidate each for the offices of Governor of Virginia, Lieutenant Governor of Virginia and Attorney General of Virginia in the General Election to be held on November 2, 2021, and

b) for the transaction of such other business as may properly come before the convention.

Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Radford City is entitled to 18 Delegate Votes

2. To set a date for nomination of constitutional officers for the City of Radford, to include Sheriff, Treasurer, Commissioner of Revenue, and Commonwealth's Attorney.

3. For the transaction of such other business as may properly come before the mass meeting.

## **Qualifications for Participation**

All legal and qualified voters of the City of Radford under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

#### **Filing Requirements**

Those wishing to serve as delegates to the State Convention shall file the form available on our web page: <u>radfordgop.com</u> at the Law Offices of John N. Dalton, Jr, 724 W Main St, Radford, VA 24141, or by mail to: The Radford Republican Party P.O. Box 1782, Radford, VA 24143.

## All delegate applications must be received no later than noon on April 12, 2021.

Pursuant to Art. VII and Art. XII of the Party Plan, all individuals who qualify under Art. I thereof, and who meet all the filing requirements set forth herein, will be declared elected at the mass meeting to elect delegates as set out herein.

#### **Registration Fee**

There will be no registration fee to a delegate to the State Convention.

#### Publication

This call will be published at Radford Republican Party Web site (radfordgop.com) and web site of the Republican Party of Virginia (rpv.org). The Unit Committee has eliminated the requirement to publish this call in a newspaper of general circulation by a two-thirds vote.

The Chairman of the Radford City Republican Committee may move the mass meeting to an alternate location, date and time upon significant hazard or unavailability of the primary location, date and time after giving due notice thereof.
