## OFFICIAL CALL Mass Meeting of the Roanoke City Committee of the Republican Party of Virginia

As Chairman of the Roanoke City Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Charles Nave, do hereby issue this call for a Mass Meeting to be held at the First Evangelical Presbyterian Church located at 2101 Jefferson St SW, Roanoke, VA 24014, starting at 10:00 AM local time (doors will open at 9:30 AM) or its alternate location and/or time on Saturday, April 24, 2021.

The purpose of the Mass Meeting will be to elect Delegates and Alternates to represent Roanoke City at the Republican State convention that will be held on Saturday, May 8, 2021, at multiple polling places across the Commonwealth. At the convention, Delegates will nominate Republican candidates for the offices of Governor, Lieutenant Governor and Attorney General to be voted for in the November 2, 2021 General Election. The convention polling place for Roanoke City Republican Delegates and Alternates shall be the Salem Civic Center located at 1001 Roanoke Blvd., Salem, VA 24153. The polling place will be open from 9:00 am until 4:00 pm.

By a Special Amendment to the State Party Plan, the Mass Meeting shall automatically elect all those persons who are eligible and who pre-file to be Delegates and Alternates, without any limit to the number. Eligibility requirements are found in the "Qualifications" paragraph below.

Because all persons who file to be Delegates and Alternates shall be automatically elected, and because there is no other business to be transacted, **the Mass Meeting shall not meet**.

## **Qualifications for Participation**

All legal and qualified voters of Roanoke City under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

## Filing Requirements

Persons who seek to be elected as Convention Delegates and Alternates are required to file a form (a) by US Mail to Roanoke City Republican Committee, 316 Mountain Avenue SW, Roanoke, VA 24016; or (b) by physically hand-delivering it to Charles Nave, the Chairman of the Roanoke City Republican Committee; or (c) by emailing a scanned or photocopied version of the prefile form to charlie@nave-law.com. The form must be received no later than 2:00pm on Thursday, April 22, 2021. Postmarks do not govern. The form for prefiling to be a convention delegate is attached to this call.

## Registration Fee

There shall be no registration fee required to participate in this mass meeting.
