Official Call for an Unassembled Mass Meeting of the Rockingham County Republican Unit Committee of the Republican Party of Virginia

As Chairman of the Rockingham County Republican Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Daryl Borgquist, do hereby issue this call for an unassembled Mass Meeting to be held for the following purposes:

1. Elect Delegates to represent the Committee at the unassembled Republican Party of Virginia 2021 Convention which shall be held on May 8th, 2021 from 9:00 AM until 4:00 PM with a voting location to be announced in our local area no later than April 24th. The Rockingham County Republican Committee shall have 193 delegate votes. The maximum number of delegates who may represent Rockingham County is unlimited.

At the State Convention, the Delegates shall:

- a. Nominate one candidate for Governor of Virginia
- b. Nominate one candidate for Lieutenant Governor of Virginia
- c. Nominate one candidate for Attorney General of Virginia

Qualifications for Participation

All legal and qualified voters of Rockingham County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for election as Delegates to the Republican Party of Virginia 2021 Convention shall file a form, which is a written statement of intention, by mail, email or in person, by appointment, to Mr. Daryl Borgquist, or his designee, by mail or personal delivery to Daryl Borgquist at 347 Wilson Way, McGaheysville, VA 22840; scanned copy by email to dborgquist@gmail.com; hand delivered to Obenshain Law Group at 420 Neff Avenue, Suite 130, Harrisonburg, VA 22801. The form must be received no later than 5:00 pm, Friday, April 16, 2021. The form for filing to be a candidate for Delegate or Alternate is attached to this Call. Postmarks do not govern.

Attendance at the Mass Meeting

As the Mass Meeting is unassembled, no meeting will be held and all qualified persons who have prefiled to be state convention delegates shall be automatically elected.

Active Military

Any Military Member who is otherwise qualified under Article I to participate in Republican Party actions and who complies with the procedures to become a delegate, and who produces valid military

identification or other proof of active-duty status shall be certified as a delegate and shall not be required to be elected as a delegate at the Mass Meeting.
