## OFFICIAL CALL OF THE 2021 SHENANDOAH COUNTY REPUBLICAN PARTY CANVASS FOR CHOOSING SUPERVISOR CANDIDATES AND DELEGATES TO THE STATE CONVENTION

As Chairman of the Shenandoah County Republican Committee, I, Randy Gilbert, pursuant to the Plan of Organization of the Republican Party of Virginia, and as directed by the Shenandoah County Republican Committee, do hereby issue this Call for a County Canvass to be held on **Saturday, April 24, 2021, from 10:00 a.m. to 2:00 p.m** at the following locations for the nomination of Republican candidates for the following purposes:

- 1. New Market Firehall (or its alternate site), for the nomination of the Republican candidates for public office of District One Supervisor (New Market and Orkney Springs Precincts);
- 2. Woodstock American Legion, 411 S. Muhlenberg, St., Woodstock, VA 22664 (or its alternative site), for the nomination of the Republican candidate for the public office of District Four Supervisor (Woodstock Precinct); and
- 3. Toms Brook Volunteer Fire Department Firehall, 3342 S. Main St., Toms Brook, VA 22660 (or its alternative site), for the nomination of the Republican candidate for the public office of District Five Supervisor (Toms Brook, Lebanon Church, and Cedar Creek Precincts).
- 4. Electing up to 515 Delegates and an equal number of Alternates to the State Convention, who will represent Shenandoah County, casting 103 votes, to be held on Saturday, May 8th at Liberty University, 1971 University Blvd., Lynchburg, VA 24515 (or its alternative site) for the purposes of nominating one Republican candidate each for the offices of Governor, Lieutenant Governor and Attorney General in the November 2, 2021 General Election, and for the transaction of such other business as may properly come before the convention.

## **QUALIFICATIONS FOR VOTER PARTICIPATION**

All legal and qualified voters of Shenandoah County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

## **MANDATORY CANDIDATE FILING AND FEE REQUIREMENTS**

Candidates wishing to seek the Republican nomination for the public office positions of District One Supervisor; District Four Supervisor; and District Five Supervisor, must file a *Declaration of Candidacy* form by mail or in person to Randy Gilbert, Chairman of the Shenandoah County Republican Committee, at 398 E. Eaglewood Ln., Mt. Jackson, VA 22842; or by electronically transmitting a scanned copy via email to

<u>SCRC-Chair@ShenandoahRepublican.com</u>. Said form may be obtained from Randy Gilbert, SCRC Chair. Request by email to <u>SCRC-Chair@ShenandoahRepublican.com</u> or call or text 540-335-4764. The form must be fully completed and signed by the candidate in order for that candidate to be deemed properly filed.

The Non-refundable Filing Fee for Supervisor for Districts 1, 4, and 5 is \$250. Checks are to be made payable to the Shenandoah County Republican Committee and shall accompany the *Declaration of Candidacy* form to be filed with Chairman Gilbert. Cash will be accepted but must be delivered in a sealed envelope. **Only those candidates for public office who file both their form and filing fee by Friday, April 16, 2021, at 6 pm will stand for election at the Party Canvass.** Should only one person file as a candidate for any public office under these requirements, then he/she shall be declared nominated and no canvass will be held for such purpose.

Those seeking to a candidate to the state convention must file a committee approved Declaration of Candidacy form by mail (available at <u>https://virginia.gop/wp-</u> <u>content/uploads/2021/03/Delegate-Form-Fillable.pdf</u>) or in person to Randy Gilbert, Chairman of the Shenandoah County Republican Committee, at 398 E. Eaglewood Ln., Mt. Jackson, VA 22842; or by electronically transmitting a scanned copy via email to SCRC-Chair@ShenandoahRepublican.com. The form must be fully completed and signed by the candidate in order for that candidate to be deemed properly filed. There is no filing fee for Delegate to the State Convention. **Only those candidates who file by Friday, April 16, 2021, at 6 pm will be eligible as a delegate to the State Convention.** Should such persons filing as a candidate for a delegate under these requirements not exceed 515, then he/she shall be declared elected and no canvass will be held for such purpose.
