<u>Unit Chairman</u>: Candidates shall submit this filing form by Friday, <u>February 21, 2020</u> and shall include with their filing form a check or evidence of a mandatory filing fee payment of \$250.

<u>Unit Members</u>: Candidates shall submit this filing form by Friday, <u>February 21, 2020</u> and shall include with their filing form a check or evidence of mandatory membership fee payment of \$40.

<u>Delegate/Alternate Delegate to First District Convention</u> (1st Dist. Convention): Candidates must submit this filing form by Friday, <u>February 21, 2020</u> and shall include with their filing form a check or evidence of a voluntary filing fee payment of \$5.

<u>Delegate/Alternate Delegate to Republican Party of Virginia 2020 Quadrennial Convention</u> (RPV State Convention): Candidates must submit this filing form by Friday, <u>February 21, 2020</u> and shall include with their filing form a check or evidence of a voluntary filing fee payment of \$35. (***<u>NOTE</u>: Failure to pay this fee means that you will <u>only</u> be able to vote in the Presidential Poll)

PLEASE NOTE: Candidates to be an official delegate to the RNC Convention in Charlotte, NC may seek election at the RPV State Convention or at the District Convention, <u>but not both</u>. If one wants to be an official delegate to the RNC Convention in Charlotte NC you need to file with either RPV or the 1St District & provide your filling fee to the respected committee per their calls.

This Form can be submitted in one of the following ways:

- Complete the Filing Form and pay online at <u>www.staffordgop.com</u>. The Form must be signed in DocuSign.
 Payment can also be made online. <u>NOTE</u> that convenience fee(s) will be charged if payment is made online.
 If a mandatory payment is not paid online, then your filing is not considered timely until payment is received;
