FAX OR EMAIL SUBMISSIONS WILL NOT BE ACCEPTED.** Illegible, incomplete, or invalid filings, and any altered or changed reproductions of the Official Filing Form, will be subject to rejection, and accompanying fees will be deemed contributions to NKCRC. Each application must be accompanied by a separate check or money order from the applicant for the Total Fees calculated above. Grouping of Filing Forms with one payment will not be accepted.
